The account balance as of October  $6^{th}$ , 2025 is \$629.58. Since May 2025, the only debits on the account are the monthly fees of \$4.00.

Prior to that the only debits were for GRIT (inclusion) mentoring. Payments were made in January, February and April via Letters of Direction to the bank by the Treasurer. The Association received funds from GRIT (now Kids included) to cover the cost of the mentoring.



The only other credits for the Association in the last year were for 4 memberships: 2 centres and 2 professional members as well as one deposit for \$854.18. Currently membership is free.

In order to be able to provide more resources and deliverables, the Association needs to look at how to increase membership and collect fees to assist with financial stability and reflect the work being done.
